Data confidentiality is of particular importance to us. We strive for our website to be comfortable and to contain the most accurate information you may be interested in. We also take care of its safe use so that you can be sure that your personal data and rights are protected.

I. INTRODUCTION

Carrying out its activities, New Occult Ltd., entered in the Commercial Register at the Registry Agency under UIC 205094685, VAT ID: BG205094685, with registered office and address of management in Plovdiv, 19 Koprivshitsa Blvd., ent. B., ground floor, contact phone number +359 87 962 8997; +359 889665885 and e-mail: st.mincheva@jorjeia.com,, processes information, including personal data.

This website is owned by New Occult Ltd. and is managed by the Company in accordance with the provisions of the Personal Data Protection Act and related legislation, including but not limited to Regulation (EU) 2016/679 ("GDPR").

This Policy aims to inform you about the way we process your personal data as an administrator, as well as your rights. New Occult Ltd. strives to provide you with accessible and accurate information on its website.

The protection of personal data is of the utmost importance to us. New Occult Ltd. does not sell your data to other companies or individuals. If we provide your data to third parties, it is our contractors who process the information on our behalf, following our instructions and applying our standard for the protection of your personal data. We strive to be as clear, specific and transparent as possible in the information about the processing of your personal data that we provide to you.

II. WHAT IS PERSONAL DATA?

Personal data is any information related to an identified individual or subject to identification (such as email address, name, age, date of birth, phone number, etc.).

III. COLLECTION AND USE OF PERSONAL DATA.

New Occult Ltd. collects, uses, stores and processes your personal data, which are needed by the Company for the provision of services and goods of New Occult Ltd. The provision of this data is completely voluntary. Your data is used to manage your account on our website and manage your purchases. They can also be used for statistical purposes, which are related to improving the quality of our services, as well as marketing activities of "New Occult" Ltd.

Below are examples of the types of personal information that New Occult Ltd. may collect, as well as the ways in which we may use it. You will find detailed information about the different types of data that are collected when you use the relevant service of New Occult Ltd. and provide information to the Company.

Each time a user opens our web page and the various menus in it, we receive information in the form of an information protocol with the following content:

- the website that referred you to us;

- IP address;
- date and duration of access;
- customer inquiry;
- the amount of data transferred;
- information about the browser and operating system you use;
- geo location.

IV. WHAT PERSONAL INFORMATION DO WE COLLECT?

- For orders and / or contracts to deliver goods: two names, e-mail address, contact phone number, delivery address of the ordered goods;
- Upon request in the contact form - name, e-mail address, contact phone number;
- For issuing and processing an invoice - your names, invoice address, delivery address, email address, means of payment used, amount of payment and product (s), date of purchase. It is possible to request personal data, which are mandatory according to the regulations;
- SMS notification for abandoned cart – phone number of the customer

V. FOR WHAT PURPOSES AND ON WHAT BASIS DO WE USE YOUR PERSONAL INFORMATION?

The main activities, goals and grounds related to the processing of personal data for New Occult Ltd. are:

- Management activities of our e-shop;
- Data for the purposes of execution of an order made by the e-shop of "New Occult" Ltd. on the basis of the contract;
- Posting and invoicing of purchases and e-shop based on our legal obligation to do so;
- Activities for managing your account on our website;
- Data related to the management of your access (identification), based on your given consent.

The personal information we collect allows us to keep you informed about upcoming discounts. We use personal information because it helps us develop, deliver and improve our products, services, content and advertising.

VI. COOKIES AND OTHER TECHNOLOGIES.

VI.I. USE OF COOKIES

In order to make your visits to the website of New Occult Ltd. as functional as possible, we use the so-called Cookies.

Cookies are small text files that are stored on your hard drive.

Cookies are small files of information that are stored in your internet browser (data on language used, connection time, web pages visited) or hard disk when visiting the site. The following is intended to provide you with the necessary and comprehensive information about the cookies that New Occult Ltd. uses on its website. We draw your attention to the fact that if you share the use of your device with others, it is possible to change the personalized nature of the action of cookies.

VI.II. WHAT ARE THE TYPES OF COOKIES USED BY NEW OCULT LTD?

New Occult Ltd. is not responsible if the Internet browser you use does not support the functions of control of use, refusal to save or delete saved cookies. If you disable the storage of cookies or delete already saved cookies depending on their type, it is possible that the site will malfunction.

VII. SOCIAL MEDIA

Your access to social networks such as Facebook, Google +, YouTube, Twitter and others, provides separate registration and acceptance of the general conditions of these sites. New Occult Ltd. is not responsible for the protection of your personal data when accepting these general terms and conditions and in this regard it is necessary to familiarize yourself in detail with the general terms and conditions of these sites.

VII.I. Facebook

This online application uses the Social Plugins of the social network [facebook.com](https://www.facebook.com), which is maintained by Facebook Inc., 1601 S. California Ave., Palo Alto, CA 94304, USA. ("Facebook").

Plugins are recognized by Facebook logos (white "f" on a blue background or "raised thumb") or are marked as "Facebook Social Plugin".

When you access a web page, your browser will immediately connect directly to Facebook's servers. The content of this Plugin will be transmitted directly from Facebook to your browser, which will link it to the website. New Occult Ltd. cannot influence the amount of data that Facebook collects using these Plugins. By linking to these Plugins, Facebook receives information that our respective website or platform has been visited. If you are logged in to Facebook, Facebook may attribute this visit to your account. If you interact with these Plugins, e.g. click the "Like" button or write a comment, the relevant information will be immediately transferred from your browser to Facebook and will be saved there. If you are not registered on Facebook, Facebook still has the ability to understand your IP address and save it.

These Facebook Plugins can be attached by site operators to their own websites or platforms. With one click on these Plugins, Facebook registered users can automatically leave a message in their Facebook profile that they like the information from the links of the site operator. The Facebook-connected Plugin "communicates" with Facebook and sends Facebook data when visiting the website - even if the user has not clicked on the Plugins.

VII.II. Google Analytics:

VII.III. Google AdWords

VIII. DISCLOSURE OF YOUR PERSONAL DATA.

IX. THIRD COUNTRY TRANSFER.

XII. YOUR RIGHTS IN RELATION TO YOUR DATA.

If you have provided your personal data to New Occult Ltd., you have the following options at all times:

- to check the accuracy, completeness and the up-to-dateness of the information of your contact information by entering your profile on the website of "New Occult" Ltd. - the right to access your personal data processed by "New Occult" Ltd.;
- the right to request the appropriate correction, deletion or blocking of your personal data;

- the right to data portability in a structured, widely used and machine-readable format;

- the right to refuse the processing of your personal data for the purposes of receiving an electronic newsletter and other marketing communications, etc .;
- the right to complain to the Data Protection Commission if you believe that your data protection rights have been violated.
